5. Evaluation Criteria & Scoring Framework

All EOIs will be assessed in line with The Malta Chamber's principles of **transparency, fairness, and competitiveness**.

Criteria	Weighting	Description
Relevant Experience & Track Record	30%	Proven track record in delivering technology/innovation solutions.
Quality & Innovation of Proposed Expertise	25%	Level of innovation, scalability, and potential business impact.
Governance & Compliance	15%	Ethical standards, data protection, and regulatory adherence.
Client Portfolio & References	15%	Breadth and quality of past clients across different sectors.
Capacity & Resources	10%	Human, financial, and technical capacity to deliver services.
Support towards The Malta Chamber	5%	Past and current support to The Malta Chamber

Applicants who are scoring above 70% will be considered for inclusion in The Malta Chamber's trusted expert network. In order to be eligible, applicants are required to be members of The Malta Chamber. Non-members may submit their application, but will only be eligible once they become members of The Malta Chamber and are above the 70% scoring.
